

Minutes of the Meeting of the Lapeer Community Schools Board of Education held on Wednesday, May 5, 2021 at the Administration and Services Center

Summer Putnam, President, called the meeting to order at 7:00 PM.

PLEDGE OF ALLEGIANCE

Schickler students Aubrey Schaffer, Journee Riddick, Myla Breslin and Aaron Wheatley led the Board and audience in the Pledge of Allegiance.

RECOGNITION

Superintendent Wandrie recognized interim Lynch principal, Joe Shoopman, for his heroic efforts in administering the Heimlich maneuver and saving a student's life at Lynch Elementary.

PRESENTATION

Schickler principal, Katie Jordan, along with learning coaches Amy Duncan, Kelly Vangel and Nicole Schons presented, Goal #3, Benchmark 3.1.C: "100% of principals and learning coaches will have individual and group coaching cycle plans to include student-centered, measurable goals and measurement (assessment) methods aligned to cycle goals and content standards. 100% of learning coaches will monitor the impact of coach cycles on student achievement. Administrative walk through observational data will measure instructional practice transfer of goals". They provided examples of what they are doing at Schickler in order to meet this goal.

BUDGET PRESENTATION

Assistant Superintendent, Mark Rajter, and Director of Finance, Danielle Corbeil, gave a budget update to the Board and others. Mark discussed the student enrollment projection through the 2023-2024 school year which shows a declining enrollment. The Consensus Revenue Estimating Conference which will be held on May 21 will hopefully shed some light on future school aid funding and help the Legislators finalize school aid funding for FY 2021-22. In addition, Danielle reviewed the ESSER (Elementary and Secondary School Emergency Relief Fund) II & III funding, which is federal funding intended to provide financial support for districts to address the ongoing impact of the COVID-19 pandemic. The monies provided will be split between allowable curriculum needs including program licenses; allowable technology needs, including student chromebooks and approved facility upgrades including air quality testing at all buildings.

Reports

Lisa Novak reported on the Finance and Operation Committee Meeting that took place on April 16, 2021 where the LACADA property update, Mayfield school sale update, lawn service bid, firewall recommendations, ESSER fund update and a bargaining update were discussed.
